Revised Order

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- AND WHEREAS, the SHRIYUT SHIKSHA SAMITY'S, SHRIYUT PHYSICAL COLLEGE, GANGEY, DIST. REWA by affidavit dt. 21.01.2015 has consented to come under new Regulations and sought for a basic une of 100 (one hundred) students with two sections of 50 (fifty) each in B.P.Ed. course, which require additional facilities
- 3. AND WHEREAS, it has been decided to permit the Institution to have a basic unit of 100 (one hundred) students with two sections of 50 (fifty) each in B.P.Ed. course, subject to the institution fulfilling following conditions namely,
 - The Institution shall create additional facilities that include (a) additional bulk-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
 - 13. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforms available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
 - III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
 - IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt, and such other documents as Indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.
- 4. NOW THEREFORE, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to SHRIYUT SHIXSHA SAMITY'S, SHRIYUT PHYSICAL COLLEGE, GANGEV, DIST. REWA for conducting B.P.Ed. programme of two years duration with an annual intake of 100 students (one basic unit with two sections of 50 (fifty) each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
- 5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affillating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- The Institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

 - f) Available infrastructural facilities;

 - g) Facilities added during the last quarter; h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - The affidavit with enclosure submitted along with application.
 - The institution shall be free to post additional relevant information, if it so desires. I)
 - Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

Recognition order dated 23.05.2003 be treated as cancelled from the date of issue of this revised order.

Hence, Recognition is withdrawn. FDEs if any, be returned.

AND WHEREAS, One Shri Pewer Subey find a PIL in the Hon'ble High Court of Hadhya Prodesh at Jatelpur. The Hon'ble High Court Directed to inspect all 5.50. Institution in the State of Madhya Pradesh Since the Institutions are saleting institutions, the inspection was conducted by NETE Hors. U/S 13 of the NETE Act.

AND WHEREAS, the Recognition was Withdrawn on DE 01.2018 from the session 2018-19.

AND WHEREAS, the institution has filed an appeal to NCTE, Hors on 07.03.2018, "The Appellate Authority vide its appealed order dat. 24.09.2018 remand back the case to the WRC, NCTE for necessary action.

AND WHEREAS, the matter was placed in 300th Meeting held on December on 17-18, 2018 and the Committee decided that " This is a case of appeal. The Appellate Authority vide order dated 27.09.2018 has remanded the case to WRC to consider the documents to be submitted by the Appellant.

"The Institution has submitted the staff profile which is not in original. Secondly, the FDR No.563143 for Rs.3.00 lakhs has matured and should be sent back to be renewed in joint name (FDR to be returned for updating by the WRO). Thirdly, the staff profile signed by the competent authority should be submitted in original."

Hence, Show Cause Notice be issued to the institution on the above points. Reply should be submitted by the institution within one month.

AND WHEREAS, the matter was placed in 310th Meeting held on August 19-21, 2019 and the Committee decided that ".. The Show cause Notice was issued to the institution vide letter dated 04/01/2019 and reply received on 24/01/2019 & 5/4/2019."
